NOTE TO CRAFTERS:

Laws enacted by the Wisconsin Legislature as of August 2009 require that a Wisconsin Temporary Event Operator and Seller Information form be completed and filed with Wisconsin Department of Revenue.

As a seller at this craft event, you may be responsible for obtaining a seller's permit from the Department of Revenue and for reporting and paying sales tax on sales at the Gingerbread Bazaar. Some exemptions apply and some crafters may not need a seller's permit, depending on number of craft shows participating in during the calendar year, dollar amount of sales, etc. If you have questions about the requirement to hold a Wisconsin seller's permit, you should contact the Wisconsin Department of Revenue at (608) 266-2776 or send an e-mail to: sales10@dor.state.wi.us.
